By submitting the registration to the FSS Team the sender (applicant) commits to implement FOSSEM according to the FOSSEM Guidelines. The program is free-of-charge. With the registration, the applicant gives permission to use the data for internal processes and listing basic data on the FSS website (company name and country). No additional data will be published or used without the prior written consent of the applicant.

The FSS Team will review the registration and provide all necessary materials.

After receiving the materials, the applicant has 3 months to conduct an initial assessment and prepare an initial action plan that must be submitted to the FSS team. Upon receiving the plan and approval by the FSS Team, the Farm will receive a "FOSSEM Confirmation". The registration is now complete. Registration is valid



for 1 year and needs to be renewed annually by submitting a progress report and action plan latest 4 weeks prior to the end of the program. By submitting the plan, the farm automatically applies for the next program year and reconfirms acceptance of this document.
